ASE TUITION DESCRIPTION: Enrollment is for children in grades K-6 only. Hours of operation are from 2:45-6:00 PM on school days during the St. Gabriel School calendar year. Late Fees of \$1.00 per minute per child will be assessed for pickup after hours of operation. Full Day Camp must be reserved 2 days in advanced to receive the reduced rate. ASE program is only available for families who have paid the \$25.00 per child registration fee in advance. Children will not be able to attend any of the ASE programs if they are not registered.
